#### Doing It Right!

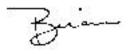

#### NCBA Board Meeting Minutes - June 22, 2001

Meeting called to order at 10:30 am by President Brian Poplin.

#### Approval of the previous Board minutes:

Linda presented the board members and guests the minutes from April's meeting. After reviewing minutes, Charles Worrell stated the outstanding expenses of \$7,189.81 were for the 2000 NCBA symposium. Charles moed to accept the minutes with changes made. Helen Jones second the motion, the board unanimously approved minutes with suggested changes.

Resignation and new appointment: Brian presented to the board the resignation of Ray Laxton. Explaining that Ray's new job commitments would not allow him to attend the board meetings or the necessary time to commit to the board. Charles Worrell moved to accept Ray's resignation from the board. Helen Jones second the motion, the board unanimously accepted the resignation. Linda then presented the board with new candidates received for the vacant board position. The candidates were Nathan Cumbie, Parker Foster and Boyd Campbell. Brian opened the floor for other nominations. With no other nominations Helen Jones moved to close the nominations for new board member. Charles Worrell seconded the motion and the board closed nominations. The board voted by closed ballots for the new board member, and elected Boyd Campbell from Catawba Memorial Hospital.

The following reports were presented and discussed by the attending Board members.

Treasurer's Report: Charles handed out the profit & loss statement dated 4/30/01 though 6/20/01. He explained the statement to board members. The total checking account for NCBA is \$26,259.94. The total of NCBA assets and cash is \$58,193.72. Brian asked Charles what the benefits were for NCBA if the checking account and the certificates of deposits were at the same bank. Charles stated he would check on it.

The liability for 2001 symposium is \$15,500.00, Charles stated this should start to decrease in September as NCBA moves toward December. Glenn Scales moved to accept the Treasurer's report. Diane Aker second the motion, the board unanimously approved.

Membership Report: Diane handed out the latest summary report of annual membership. Only one new member added since the 2000 symposium. That brings the total membership to 458. Diane handed out the Board member list, and an updated committee member list. Sally Goebel moved to accept the report as given. Helen Jones seconded the motion, the board unanimously approved.

Education Report: Dan informed the board that the project management class had been cancelled due lack of interest. The class will be offer at the 2001 symposium. The Zoll defibrillator class in Raleigh is still on. Dan stated there's has been a lot of interest for this class. Dan informed board, most of the manufacturer's would like to schedule for 1 year in advance. The idea of scheduling these classes a year in advance would help advertising and class participation. Helen Jones moved to accept report as given. Sally Goebel seconds, board unanimously approved.

Scholarship Report: Sonny Richards informed the board that he has been in contact with both directors at colleges. Sonny is planning to send the nomination forms to the financial aid departments at

both schools in August. The scholarship deadline is 60 days prior to Symposium. Diane Aker moved to accept report as given. Charles Worrell seconded the motion, board unanimously approved.

Rules & By-laws: No report given. Helen Jones asked the board what the possibility of changing the structure of officer elections. Bringing up the question of running for a specific office during the general election process. After a lengthy conversation board decided not to recommend changing the structure of elections.

Newsletter: Glenn Scales informed the board that the latest newsletter has been mailed. Glenn informed the board that he's been investigating cost for a new publishing company. Glenn stated that the newsletter would be changed to Kinko. The previous cost for printing a 12-page newsletter was about \$967.00. The projected cost for a 12-page newsletter using Kinko's would be about \$325 less plus the postage costs are expected to be less.

Glenn informed the board what needs to be included in next newsletter and Brian placed a deadline of July 6 for reports from board officers. Also, information on the hotel, golf, and nomination forms for professional and manager of the year. Helen Jones motion to accept the report given and changing to Kinko printers. Diane Aker seconded the motion, board unanimously approved.

#### Biomed Shop Takes Big Step! By Charles Worrell, CBET

TRC's biomedical shop has taken another step into the world of computer automation.

Thanks to the software talents of biomed Thomas Austin, we can now dump individual equipment "PM Reports" into our own work order format directly from the DNI medTester 5000 system consisting of the 5000, barcode scanning gun, Impulse 3000 defibrillator, and Oxitest +7 data.

Using DNI's wedge module to tie the outputs of the Impulse 3000 and the Oxitest +7 to the medTester 5000, we can now collect all inspection data into one form and transfer it directly into a specific equipment inspection report. This has reduced the error possibility and time in creating inspection reports.

The Medtester 5000 is taken to the test sites. Safety and operational tests are made, data is collected by the system, and then at the end of the day is dumped into our data base from the 5000, printed, and signed. By using employee ID numbers, hard copies will not be necessary. An ongoing software history log for each inspected unit is created.

This conserves biomed time and gives an outstanding history record for your Joint Commission reviews.

# AAMI Convention - Baltimore, MD by Steven Comas, Moses Cone Hospital

I was very fortunate to be able to attend the AAMI convention in Baltimore June 9-12. I believe every bmet, vendor, or anyone involved with medical equipment should experience an AAMI convention at least once in their career.

I attended several classes during the convention, but one class I felt was very important to the job I perform and what the future might hold for others in my field.

ECRI and the FDA presented a class titled Medical Mishap, Device Defect or Crime. They discussed the procedures that bmets should take in case a possible incident occurred. ECRI told the class that equipment should not be turned off until the bmet is sure that the error codes and memory are safely stored or logged. They also discussed lawsuits and court cases where bmets might have to take the stand. The equipment that they have seen with lawsuits and court cases are the following; Pediatric Surgery, Cardioplegia, Anesthesia Equipment, Apnea Monitors, Electrosurgical Units, Ventilators, PCA Pumps, and hospital equipment at patient homes.

They stressed that the Risk Manager should be the liaison for the hospital and that bmets should contact them for the policies and procedures.

## Computer Tech Tips by Glenn Scales, CBET

## Convert Adobe PDF Files to Word or WordPerfect Documents

Adobe Acrobat's Portable Document Format files are popular, especially on the Internet, but you can't edit or save them in another format with just the free Acrobat Reader (you need the full version of Adobe Acrobat to do so). However, you can extract the text from a PDF file and paste it into either a Word or WordPerfect document.

Open the PDF file in Acrobat Reader, select Edit, Select All (or press Ctrl-A), and then choose Edit, Copy (or press Ctrl-C). Now open a new or existing document in either Word or WordPerfect and select Edit, Paste (or press Ctrl-V) to insert the text at the current cursor location. There's a catch, though: Acrobat Reader's Select All command selects only the text on the current page, so you'll need to repeat the process for each page of the document. And once the text is in the word processor's document, it'll probably look a fright, what with all the strange characters, odd font sizes and styles, and general PDF mayhem. You'll have to do your document formatting manually.

(Legal note: Be sure to observe copyright laws when moving text from PDF files into your own documents.)

#### **Make Precise Selections**

If you select a range of cells in a Microsoft Excel worksheet, for example, and part of the area you select isn't visible, you may select too few or too many cells if you simply click and drag with the mouse. This is especially true on notebooks, whose pointing devices are lousy at clicking and dragging.

The Shift-click technique, however, works when you make selections in any Windows application. To select a group of visible and invisible cells, click the upper-left cell of the desired selection, navigate to the bottom-right cell of the area you want to select, and click that bottom-right cell while holding down the Shift key. Doing so will select the entire range. This technique also works when you're creating a formula and need to give it a range of cells to calculate.

To select a group of nonadjacent cells when creating a formula or formatting a group of separated cells, hold down the Ctrl key while you select each cell in turn. If you make an error in selection, Ctrl-click the cell again to deselect it.

#### **More Selection Tips**

The Shift-click technique will work in virtually any Windows based application. Some other conveinent shortcuts for selection text include:

Ctrl-Shift-Home: Selects all text from the current cursor position to the beginning of the document

Ctrl-Shift-End: Selects all text from the current cursor position to the end of the document

Ctrl-Shift-right arrow: Extends selection from the current custor position to the right, one word at a time. Ctrl-Shift-left arrow extends the selection to the left.

Ctrl-A: Selects the entire document

#### **Change the Date Format**

There's a trick to changing the default date and time format in Word 97 and 2000. Select Insert, Date and Time, pick a format, and click Default and Yes in the confirmation box. Now when you insert a date in your document, press Alt-Shift-D instead of selecting 'Insert, Date and Time.' This shortcut will insert the date, using the new format. If you select the menu command, it will insert the date in Word's default format rather than the date format that you selected.

#### Find and Replace Invisible Items

The find and replace tools in Word 97 or 2000 aren't much help when you're working with invisible items—tabs, paragraph marks, page and section breaks, and the like. You could use Word's shortcut characters to represent these items, but they're hard to remember. To find and replace invisible items without taxing your memory, select either Edit, Find or Edit, Replace, and place your cursor in the 'Find what' or 'Replace with' field in the resulting dialog box. Click More to expand the dialog box, and then choose Special to display a list of characters representing nontext functions. From the list, select the item you want to search for or replace with, and click the appropriate button to carry out your search or replace operation. To insert more than one special character in a dialog box, or to combine a special character with normal text, repeat the above process as necessary.

#### **Get Quick Formatting Info**

You can get instant information about the formatting of any text or graphic in a document by pressing Shift-F1, which turns the mouse pointer into a question mark with an arrow. Click the text or graphic in question to call up a box showing formatting information.

Extra tip: After pressing Shift-F1, you can also click any command, icon, toolbar, or other feature in Word's window to see a description of that item. Just press Esc to return the mouse pointer to its normal function.

# WANTED

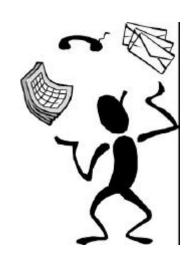

- Made significant contributions to the mission of the institution which were clearly above and beyond the normal assigned tasks.

#### **Community Contribution**

# It's About Time! Should We Keep Computer Clocks Accurate?

As each of us gets older our experiences allow us to identify changing patterns. Sometimes these patterns seem to predict impending problems. I would like to relate six events that to me suggest such a pattern; and I ask <u>you</u> what, if anything, we should do about it?

- 1. Several years ago, I investigated an accident that related to the failure of a registry nurse to activate the default alarms of a cardiac monitor. The particular monitoring system required the pressing of a switch to activate the alarms. After the alarm failed to sound, the nurse wondered why no alarms had occurred? In her investigation she noted that the print out of the printed record was one hour earlier than the adverse event. This incorrect timing led her to believe that since the printed record was obviously incorrect that the complete system was not functioning properly.
- In another investigation, a fetal activity monitor appeared to have two fetal activities occurring when the mother had only one fetus. During the investigation, I interviewed the hospital evening shift. When I looked at the printed fetal activity strip I kept referring to the time on the printed strip. After several comments one nurse asked why the time I referred to was some 45 minutes prior to the actual event. The time printed on the recorded strip was not only off but also off almost an hour. The nurse was confused about the discrepancy to the degree that she could not concentrate on other questions, until I indicated that the time on the strip was apparently off about the time of a "fall back" due to daylight savings time. (And, oh yes, someone had taken a previously recorded strip, refolded it and placed it back into the machine, accounting for the two fetal activities.)
- 3. About 1996, I investigated an over-infusion event. I looked at the event memory of the infusion pump and found that it was off by 48 minutes. After I found out the actual time of the event I had to compensate for the error. Once they were compensated for, the cause of the event became obvious. A similar occurrence was related to an intra-aortic balloon pump.
- 4. Recently in a Washington state hospital, I was talking to a biomedical engineer when a call came in that indicated that a cardiac monitor required adjusting. The engineer asked if I would like to join him to respond to the call. The nurse in a Post Anesthesia Recovery area noted

that the monitor she was using was reading 6 minutes later than real time and wanted the monitor adjusted. When I asked why the concern for 6 minutes the nurse said that patients arriving from surgery were to have vital signs taken every 30 minutes and 6 minutes was a significant portion of that time. Note that I am not trying to justify nursing concerns for a 6-minute error but only to describe a clinical circumstance of importance to that nurse.

- 5. I asked the biomedical engineer if anyone else in that hospital seemed concerned about computer clocks. He said that on one occasion a Nuclear Med technologist called and said that he wanted all of his Nuclear Med equipment set for the same time and that the time should be the same as the clock on the wall. This was certainly an interesting, if not surprising, requirement.
- 6. Time and date stamps on defibrillators and monitors document critical events in a hospital's clinical activities. This documentation is placed in the patient's record not only for medical purposes but to possibly become a legal record as well. Any timing errors may later be introduced into court to prove either a defendant or plaintiff's viewpoint of the clinical intervention.

Each of these incidents appeared to occur for different reasons. The first had caused the nurse to believe the cardiac monitors were malfunctioning. The second confused the staff for some period until the discrepancy in time was understood. The third required additional effort to assure the time of the adverse event was the same as the time in the infusion pump memory. The fourth was an attempt to assure identical timing in several clinical environments and the fifth was trying to assure the same timing of all equipment in one clinical area. The sixth relates to the medical/legal documentation of patient care.

I have described for you a series of six occurrences that have happened to me. First, I would like to know if they or others have happened to you? Second, is time an important enough factor in the clinical setting that we should pro-actively make sure that all of the computer clocks are set correctly? If so, who should be responsible for setting clocks; BMETs/CEs or nurses?
