My First Year BMET Experience Larry Riley, II Duke Univ. Medical Center

The first year as a BMET consists of many new experiences. For myself, I entered the field feeling that I did not have the knowledge required to perform the tasks ahead. Would I feel comfortable with my work, how would I get along with my co-workers and most of all, how would I find my way back to the shop? After becoming familiar with a few pieces of equipment and finding that others were glad to offer their knowledge and suggestions, I found that there was little reason to get stressed. I began to assist others with troubleshooting and soon found that I too had something to contribute and was routinely getting asked for advice.

Less than two months after being hired I found myself on an airplane in route for technical training on some very sophisticated equipment. In my first year I was given the opportunity to attend three major training classes. Throughout the year I learned many new things and was able to apply much of the knowledge that I received in the classroom. As a first year BMET, training is a great way to beginning building your equipment knowledge and your worth to the institution. The training received can also help you decide as to what types of coverage you like to provide and where you would like to head in the future.

Experiences in the first year helped me prepare for future situations. Working with people outside of my department has helped build communication skills. Troubleshooting a wide variety of devices helped build my troubleshooting skills, while at the same time, helping me get more comfortable with my role in the hospital. After talking with technical support technicians from various manufacturers, I quickly learned what types of information, when gathered prior to making the call, can help to speed the call. I also learned that my call is important and that it would be answered in the order in which it was received!

I enjoyed my first year and hope that those to come are just as enjoyable. With help others from mv troubleshooting skills continue to improve, it is easier to talk with customers and I can find my way back to the shop. As with many jobs, the around people you definitely make all the difference.



A "Kodack" Moment

The 2003 graduating class from Caldwell Community College and Technical Institute had the pleasure of hosting a two-day seminar presented by Larry Kodack, PhD, CBET. This seminar focused on laboratory equipment and procedures. Dr. Kodack has an extensive background in the laboratory area with an undergraduate degree in zoology from UNC Chapel Hill and a PhD in Biochemistry from Duke University. Larry is a Senior CBET in the Clinical Engineering Department at Duke University Hospital.

Our "Kodack" moment began with an overview of some of the guiding agencies in the medical laboratory. Agencies such as CAP—College of American Pathologist, FUDT— Forensic Urine Drug Testing, RLAP—Reproductive Laboratory Program and AABB—American Association of Blood Banks.

After the introduction into the standards set forth for the laboratory, on we went into the types of equipment found in the laboratory. Larry not only spoke as to the types of equipment in the hospital lab but also the underlying principles of operation of how the equipment performed their analysis or task. Larry and the students covered many types of equipment in the two-day seminar. Students were given the opportunity to research materials handed out by Larry on different equipment for presentations and Larry gave feedback on their presentation and added much of his knowledge and experience with that particular equipment. As an employee of a teaching hospital such as Duke you could tell Larry prescribed to the teaching philosophy of "see one, do one, teach one". This is an excellent way to get information into long-term memory. Studies have shown that a student has about a 90% retention rate of information if the student has to teach the material or has immediate use of learned material. I applaud Larry for his approach in teaching the seminar.

As mentioned earlier many types of equipment were covered in the two days. An overview of the equipment covered is as follows:

We finished the seminar with a game of stump the teacher. Larry took questions from the students such as how do blood gas analyzers work to why is it so cold in the operating rooms. Let me just say it is most difficult to stump Larry in the lab area or hospital for that matter. I didn't keep score of this little game but if I had to guess I would say Larry 50, Students 2.

In closing I would like to thank Larry for sharing his knowledge with the students and thanks to the Duke Clinical Engineering Department for allowing the time for Larry to help with training of the future BMET's. This was a great learning experience for the students, which I'm sure they will remember for a long time.

He has spent the last seven years as Technical Support Representative in the Clinical Engineering field for ServiceMaster, now ARAMARK, covering five states. Ken sees these "Challenges" for the NCAB today:

1. With today's challenges for time and money, the education classes needed to draw attendees is far greater than while I was active. (president). The role of management has advanced with technology and managers are spending more and more time just meeting the demands for regulations and compliance. Technical seminars now must cover a greater knowledge level from Entry Level to the most Senior

Technician. The working manager (part time manager and part time hands on tech) is being reduced by the day-to-day requirement of the facility equipment users and technology assessment. This leads to more committee meetings with information collection and evaluations. (Pre-purchase evaluation is just one.)

- 2. The training budget, since Biomed is considered an expense and not revenue, is examined very closely for investment payback with the reduction of a contract or increased up-time on equipment. Training to remain certified is not enough and must relate to an expense reduction.
- 3. The greatest interest of management falls to issues of the day like HIPPA, Risk Management and JCAHO. Issues really needed like time management, customer satisfaction and communication skills that would help control these major issues can not draw the manager away from their facility.

Our 1985 President: Mike Trumbore. Mike is with Carolinas HealthCare System in Charlotte, NC. He

How to Disable IE Image Resizing

Have you ever noticed that pictures seem corrupted and messed up in Internet Explorer? It's like they've been poorly resized by a virus or something. Well, it's no virus, it's Internet Explorer! By default, Internet Explorer will resize pictures if the Internet Explorer window isn't large enough to fit the entire picture. I suffered through this behavior for a long time, and finally figured out how to fix it. Now you can fix it too!

- 1. Open Internet Explorer and click the Tools menu. Click on the Internet Options command.
- Click on the Advanced tab. Scroll through the list of options and find the Enable Automatic Image Resizing entry. Click on the box to remove the checkmark.
- 3. Click Apply and then click OK.

With the image resizing feature disabled you'll be able to see pictures that otherwise wouldn't have looked right in Internet Explorer.

Windows XP Does Have a Back-up Utility

Insert your Windows XP disc into your PC. Click exit if your installation screen comes up. Now go too your CD drive in My Computer. Right-click and select open. Choose VALUE ADD\MSFT\NT BACK-UP FILE. In the "files of type" drop down list be sure that "select all files" is on.

Click on the NTBACK-UP.msi file and click okay. Click the finish button and now go over too the start button\ALL PROGRAMS\ACCESSORIES\SYSTEM TOOLS\ and there it is now. BACK-UP FILES... Great little tool that Microsoft never should have hidden.

Sick of Inserting WinXP CD When Computer Asks You To!

Sometimes you are installing something, and you are asked to insert the Windows XP CD, and sometimes you're just too lazy to get it, or you don't have it at the moment. Well here's something that'll definitely solve that problem...

- 1. Insert your Windows XP CD
- Click on Perform Additional Tasks
- 3. Now click on Browse this CD
- 4. Look for the I386 folder, right click on the folder and copy.
- 5. Get into My Computer
- 6. Right click on your C: drive and paste.

From now on you never need that CD again, I mean never ever...

Disable Unnecessary Services to Free System Resources

Services are programs that run when the computer starts up and continue to run as they aid the operating system in functionality. There are many services that load and are not needed which take up memory space and CPU time. Disabling these services will free up system resources which will speed up your overall computer experience. I recommend that you sort through the list and read the descriptions to decide if you need that service depending on what you want to do with your computer. Remember, you can always turn the service back on if you find that you need it in the future. Below is the procedure to turn off a service.

- 1. Click the Start button.
- 2. Select Run from the bottom of the right column.
- 3. Then type services.msc in the box and click OK.
- 4. Once the services window has loaded we are ready to turn off unneeded services.
- 5. Find the service in the list and select it with the mouse.
- 6. Right click and select Properties.
- 7. Once the properties windows has loaded, locate the Start up type drop down box and select disable.
- 8. Then just click OK and the next time the computer starts the service will not be loaded.

Remove Hibernation File

If you do not use hibernation, make sure you do not have it enabled, which reserves disk space equal to your RAM. If you have a hidden file on the root directory of your C-drive called hiberfil.sys, hibernation is enabled. To remove that file, go to Control Panel, select Performance and Maintenance, Power Options, Hibernate tab, and uncheck the Enable hibernation box.


