I. Call to Order

II. Review of Minutes

III. Election of Officers

IV. Reports

Linda submitted Income/Expense statement and P & L statement for November 2003 through January 2004. Suggestions were made for ways to eliminate expenses for the symposium. Food and beverage costs were the greatest expense. Donations for next year already total \$5000.

Glenn submitted the Annual Membership Summary report for calendar year ending December 31, 2003. Total membership was 523. 
New Board Member Chad Granade


