Adding "CBET" behind your name will help position you for the next level in your career!

As I believe I mentioned in a prior newsletter, we plan to offer one stand-alone class each quarter and it looks like the first two quarter classes are ready to go. We are currently trying to coordinate an ECRI Incident Investigation 1-day course, but we are still fine tuning the details. 


**Maull Biomedical Training** was started in 2008 by Steve Maull in an effort to provide the biomedical service industry training that did not exist but was in demand.

Currently we are using both Wild Apricot and Reg-on-line for membership data base and registration needs. We do not want to incur the expense for both. Wild Apricot is not really able to meet our needs for both registration on line and maintaining a membership data base. Jeremy is building a membership base that will reside on the website so we can eliminate Wild Apricot and its expense and can rely on Regonline for the registration. Integrating PayPal into our website will incur a one-time cost, approx. \$140.00 for a license, first year we would be allowed to use their code and get updates, after that can renew for \$75.00. This keeps the liability with PayPal. John Shore moved we accept Jeremy's work and use the PayPal app for the code. Tony seconded, the motion passed. Jeremy showed us the new NCBA website that is still under construction. He demonstrated applying for and paying for a membership. This will eventually tie in to symposium and class registration. There will be different access for members based on their classification within the association. Under the board member access there will be tabs for each office that will have tools that that officer can use to update information on the website regarding their duties. The president would have access to the president and board tabs but not the tabs for other positions. Access will be flexible so that more than just the board seat would be able to use the tab. Board members will be granted access to various tabs as needed, i.e. the vice president will have access to the education tabs because that education planning is in the vice president's job description and education committee members would have access to the VP tab. Jeremy asked for any suggestions for improvements or enhancements to the website. The board thanked him for the great job he has done on this tremendous project.

#### Membership Secretary:






