2014 Proposed By Law Changes

Over the course of the past six months, the NCBA Rules and By-Laws Committee has developed the recommended changes to the December 2004 By-Laws in order to bring them up to date and to reflect the operational and technological changes that have taken place over the past ten years.

These 16 changes will be presented at the NCBA Business Meeting to be held at the Annual Symposium on Wednesday, September 3rd and will be voted on by the attending members for adoption immediately following the Business Meeting. Some of the changes are minor wording issues, but others will fundamentally change the way in which the NCBA operates, and in a manner that the Board feels will benefit our organization as we continue to grow and develop.

One of the biggest changes is that with the adoption of these changes, membership in the NCBA will be free and membership will continue for life. Membership expiration for current members will no longer be in effect and new members may join following our usual process, except that dues will no longer be collected. Inactive members will be able to log into their online profile and change their membership status from inactive to active. Former students can make this change as well as change their membership category from student to individual, as long as they meet the requirements for individual membership.

I will be available at the NCBA Symposium Registration Desk throughout the Symposium to answer any questions that members may have regarding any of these proposed changes. They will also be described at the Business Meeting and questions can be addressed prior to the voting. You can also e-mail me at pres@ncbiomedassoc.com. I'm looking forward to seeing you at the Symposium. All the best.

1. Delete Article III, Section 2, Paragraph A. 4.

At least a Certificate of Completion from the North Carolina Department of Labor, Apprenticeship Division as approved by the NCBA Apprenticeship Committee, or

2. Change Article III, Section 2, Paragraph C

Current: The Honorary member shall have no vote.

Proposed: Each honorary member shall have the right to vote in all association membership meetings.

3. Change Article III, Section 2, Paragraph A

Current: Application form shall be completed by applicant ...

Proposed: Application for membership shall be completed by the applicant, either as a written form or as an electronic submission...

4. Change Article III, Section 2, Paragraph A

Current: Applicants shall be provided with a copy of the Association's By-Laws upon acceptance as members.

Proposed: Approved applicants shall be given access to the Association's web site, which allows downloading the current By-Laws.

5. Addition to Article III, Section 3

Insert as Paragraph B & renumber the following paragraphs: All persons attending the Annual Symposium of the North Carolina Biomedical Association will be added to the membership records of the NCBA and that membership shall continue indefinitely as described in Article III, Section 4. The Membership Secretary shall review the Symposium attendee list and ensure that each attendee is added to the membership in a category that is appropriate and as defined in Article III, Section 2.

6. Change Article III, Section 4

Delete all material

Proposed: Individual, associate, student and institutional members shall pay no fees. Once membership is established, membership will continue indefinitely till the member changes their status to "Inactive", or membership is rescinded by action of the Board of Directors. Students will be able to change the status in their online profile from student to "Individual" or "Associate" as long as they meet the requirements in the appropriate category as defined in Article III, Section 2.

7. Change Article IV, Section 4, Paragraph F

Current: Shall keep an updated list of the members ...

Proposed: Shall maintain an accurate record of the members ...

8. Change Article IV, Section 5

Proposed: Change all references to the number five to the number six.

9. Change Article IV, Section 13

Current: Those elected will assume office the following January 1st.

Proposed: Those elected will assume office at the next regularly scheduled meeting of the Board of Directors.

10. Article IV, Section 15

Delete all material

Proposed: Directors shall be elected by selecting the six (6) highest vote counts from the ballots submitted during the Business Meeting. These six individuals will assume office at the next regularly scheduled meeting of the Board of Directors.

In the event of a tie in the vote count, both individuals will be selected as one of the six elected members unless the tie is for sixth place. A tie for sixth place will be broken by a ballot of the serving board members present at a called meeting of the Board of Directors, immediately following the ballot counting process.

11. Article V, Section 1

Current: A quorum of the general Membership shall be constituted at regularly scheduled meetings if one third (1/3) of the voting Membership in good standing ...

Proposed: A quorum of the General Membership shall be constituted at regularly scheduled meetings if at least ten percent (5%) of the voting Membership in good standing ...

12. Article V, Section 1

Current: A quorum of General Membership shall be constituted at special meetings if one third (1/3) of the voting Membership in good standing ...

Proposed: A quorum of the general Membership shall be constituted at regularly scheduled meetings if at least ten percent (5%) of the voting Membership in good standing ...

13. Article V, Section 11

Current: "...will be made by the Recording Secretary in writing to all members in good standing..."

Proposed: "... will be made by the Recording Secretary to all members in good standing using any combination of written, oral or electronic communication..."

14. Article V, Section 12

Current: Upon the written request signed by at least one third (1/3) of the members in good standing ..."

Proposed: "Upon the written request signed by at least ten percent (5%) of the members in good standing ..."

15. Article VI, Section 1

Proposed: Delete the reference to the Apprenticeship Committee

16. Article IX, Section 4


Current: Delete the entire section

Proposed: The Recording Secretary will be responsible for ensuring that the current version of the NCBA By-Laws will be available for electronic dissemination or individual downloading by all members in good standing.

** Article IV, Section 15

My interpretation of this provision leads me to believe that in order to be elected, each Director must receive at least 50% + 1 of the cast ballots and that is not how we do it and have not for years. We currently select the 6 highest vote counts. Plus there is no defined provision for what happens if we have a tie for 6th place. By the time we determine that a tie has occurred, the business meeting is closed and the voting members are in classes.

Symposium Headliners

"The Revised CMS Mandate: Lies, White Lies, and Politics"



The NCBA is very excited to have Binseng Wang and Salil Balar from ARAMARK Healthcare Technologies present a session titled, "The Revised CMS Mandate: Lies, White Lies, and Politics" on Thursday, September 4th.

The Centers for Medicare & Medicaid Services (CMS) issued a revised interpretation of the Conditions of Participation on 12/20/2013, superseding the document issued in December 2011. This revision (known as S&C 14-07) allows hospitals and contractors to establish an Alternate Equipment Management (AEM) program for biomedical equipment if they can prove that the AEM is "safe and effective."

However, imaging, lasers, and "new" equipment (for which there is insufficient history) is required to be maintained according to manufacturers' recommendations. In addition, hospitals are required to divide equipment into two categories: critical or non-critical, regardless of which maintenance strategy is adopted. The maintenance of critical equipment will be closely scrutinized by surveyors.

Although this revision is a significant improvement over the 2011 document, several challenges remain. No definition of critical equipment was offered, so each hospital will have to define its own list. While laser manufacturers are required by FDA to provide maintenance recommendations, no others have this obligation; so it is unclear how clinical engineering (CE) professionals can comply in the case of manufacturers declining to provide those recommendations. Evaluation of AEM safety and effectiveness requires large amount of data which takes time to compile, and there are very few maintenance-induced patient incidents for adequate analyses. Some possible implementation ideas will be discussed.

Binseng Wang is Vice President, Quality and Regulatory Compliance, with ARAMARK Healthcare Technologies. He began his career in Brazil, working in academia, hospitals and a large health system. In the US, he was a visiting scientist at NIH and a vice president at MEDIQ. He earned a doctorate from Massachusetts Inst. of Technology and certifications as CCE and ISO 9001 auditor.

He has been elected fellow by the American College of Clinical Engineering and American Institute of Medical and Biological Engineering.



Salil Balar is Director of Technology Management with ARAMARK Healthcare Technologies. He worked for Arnot Ogden Medical Center, Elmira NY, and Beaumont Hospitals, Royal Oak MI, before joining ARAMARK Healthcare Technologies. He holds a Bachelor's in Mechanical Engineering degree from Guja-

rat University, MS Biomedical Engineering from Iowa State University, and MBA from Wayne State University.

This highly relevant program will provide exceptional guidance and interpretation for healthcare technology managers in the NCBA. While there has been some confusion about this since it was first introduced, the latest revision by the CMS may be an improvement, but there are multiple strategies for implementation and the ARAMARK team will provide guidance on compliance strategies and methods of data collection and interpretation. NCBA members are encouraged to plan to attend this valuable program.

Binseng and Salil are frequent presenters at AAMI, MD Expo, and of course, the NCBA. Both have been long time contributors to the NCBA News as well as NCBA Symposium classes and stand-alone programs.
